

PROMOTION ADDENDUM | KOTZEBUE GRAND OPENING SWEEPSTAKES

This Addendum (“Promotion Addendum”) to the Credit Union 1 Master Official Rules (“Master Official Rules”) describes certain rules specific to the *Kotzebue Grand Opening Sweepstakes* and incorporates the Master Official Rules by reference. THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES. If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

NO PURCHASE OR PAYMENT IS REQUIRED TO ENTER OR WIN. MAKING A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

ELIGIBILITY: In addition to the eligibility requirements outlined in the Master Official Rules, this promotion is open to individuals at least 18 years of age, who are legal residents of Alaska, and whose primary residence is in the Northwest Arctic Borough. Participants who meet the eligibility requirements and are not CU1 members who open a savings account with Credit Union 1 within the sweepstakes period or existing members who visit the Kotzebue branch during business hours and mention this sweepstakes within the sweepstakes period are automatically entered. The promotion is also open to those who use an alternate method of entry.

SWEEPSTAKES PERIOD: Sweepstakes begins February 14, 2025, and ends February 28, 2025, at 11:59 PM (“Sweepstakes Period”).

HOW TO ENTER: To participate and enter this Sweepstakes, you (“Entrant”) must utilize either of the following methods of entry for this Sweepstakes. Sponsor will not accept entries that fail to follow the instructions outlined in this Promotion Addendum, and Sponsor is not responsible for failure to see or receive an entry.

(i) In-Person Entry, Existing Members (Entry Method 1):

- Existing Credit Union 1 members who meet eligibility requirements can visit the Kotzebue branch during the Sweepstakes Period within normal business hours and mention the Sweepstakes to CU1 staff to enter.

(ii) In-Person Entry, Non-Members – Open a Savings Account (Entry Method 2):

- Eligible individuals who are not existing members may enter by opening a Credit Union 1 savings account at the Kotzebue branch during the Sweepstakes Period.

(iii) Mail-In-Entry (Alternate Method or Entry Method 3):

Eligible Participants who have not opened a Credit Union 1 savings account during the Sweepstakes Period may enter by mailing a 3x5 card ("Mail-In Entry") labeled "Kotzebue Grand Opening Sweepstakes" with Entrant's complete name (no initials), valid e-mail address, street address (including zip code), and telephone number and mail it, with sufficient postage, to Credit Union 1, attn.: Marketing 1941 Abbott Rd, Anchorage, AK 99507. TO PROTECT YOUR PRIVACY, WE RECOMMEND YOU SEND THE 3x5 CARD IN AN ENVELOPE. Limit of one (1) Mail-In Entry per Eligible Participant. All mail-in entries must be postmarked February 28, 2025, and received no later than March 7, 2025, to be eligible for the Sweepstakes drawing. Proof of mailing does not constitute proof of delivery. Mail-In-Entries must be legibly hand-written. Mail-In-Entries received without a verifiable and legible return address will be deemed incomplete and invalid.

ODDS: Odds of winning will depend upon the total number of entries received during the Entry Period.

SELECTION OF WINNER(S): Winner selection is at the sole discretion of the Sponsor. For this Sweepstakes, Sponsor will randomly select one (1) winner from all eligible entries in the Sweepstakes Period.

NOTIFICATION: The potential Winner will be notified at the e-mail address and/or telephone number (in the sole discretion of the Sponsor) (the "Prize Notification") associated with their Credit Union 1 account. If any potential Winner does not respond to any such Prize Notification within 48 hours of the time of initial attempted Prize Notification or declines the Prize for any reason, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential Winner may be selected from among all remaining eligible entries.

PRIZE(S):

- (i) Selected Entrant will receive a Polaris S25CED5TSU 550 Voyager LXT NorthStar Edition 2025 snowmachine (valued at \$12,636.90) with shipping to Kotzebue (valued at \$999.21) covered by CU1 (*Total Estimated Prize Value: \$13,363.11*). The Winner will be responsible for pickup from Kotzebue. If prize has not been claimed and transported from the property within seven (7) days of delivery, Winner will forfeit prize.

The name of the winner will be available at the termination of the contest at any CU1 location or online.
